

Scaling up Improved Sheep Fattening Practices and Technologies in Ethiopia

Implementation of Technologies for African Agricultural Transformation (TAAT) Livestock Compact

> TAAT Progress Report September 2018





General Progress

Activites for the month of September included the following:

- Identification and employment of project enumerators.
- Formation of 5-member sub-committes within Community-based Breeding Programs (CBBPs) to oversee TAAT project fattening activities.
- Identification of existing youth groups, formation of new youth groups and identification of potential champion farmers.
- Mapping and profiling of youth groups, youth group members and champion farmers.
- Memorandum of Understanding between ICARDA and National Agricultural Centers (NARS)
- Formation of a Community of Practice (CoP) in each project site.

Enumerators

A total of 21 enumerators (6 female; 15 men) were employed across the project; Bonga (7 males), Doyogena (3 male, 3 female), Menz (5 male, 3 female). These are trained facilitators who have previously worked with the NARS researchers on various projects and are, therefore, familiar with their respective *Kebeles* and farmers. Their roles and responsibilities are as follows:

- Facilitate in mobilization of project beneficiaries for meetings and trainings.
- Data collection of ram weights, feed resource utilization and disease occurrences.
- In collaboration with youth group leaders, they ensure communication and coordination within youth groups runs smoothly.
- Ensure communication and coordination between youth groups and champion farmers is regular and runs smoothly.
- Liaise between sub-committees of CBBPs with youth groups and champion farmers.

Formation of sub-committees with CBBP cooperatives

This project found it important to involve the existing CBBP cooperative in oversight engagement because i. ICARDA and the NARS partners have long-standing collaboration with these very established and actively functioning cooperatives. i. Majority of sheep farming households in the target sites are members of the CBBPs. iii. Most of the rams fattened by farmers in the target sites are rams that not selected for breeding by the CBBPs. Members of CBBPs are obliged by cooperative by-laws to sell off unselected rams to avoid these rams breeding within the communities. It is thus, normal for farmers to fatten these rams and sell them off. A total of 12 sub-committees with a total of 60 members (Table 1) were formed across the 12 CBBPs in the target sites (Table 2).

Selection and profiling of youth groups

Profiling and mapping of existing and registered youth groups was done both by ICARDA, NARS, CBBP officials as well as *Woreda* (district) and *kebele* (Village) level officials and local administrators (Fig. 1-2). All but one group in Menz had ceased fattening as a group and members were fattening individually. This was as a result of challenges that formed groups had encountered. The groups had been formed by the Cooperative and Job creation offices in line with the Government's strategy to promote youth employment. However, in all 3 regions of Menz, Bonga and Doyogena, groups formed were only given a one-day basic training on entrepreneurship with no further follow-up. No start-up funds were provided, neither were they linked to any microfinance institutions, no land and/or shed was allocated to them for group sheep fattening and, in most cases, the youth members were not familiar to each other, nor did they live close to each other. These conditions were no recipe for successful group operations.

Therefore, for purposes of this project, new groups were formed. Criteria for member participation included:

- Currently undertaking sheep fattening for sale.
- Ownership of at least one ram to fatten.
- Willingness to practice short-term fattening and improved husbandry methods.
- Willingness to participate in capacity building activities.

A total of 475 youth (Table 2) who were either jobless, have relatively low incomes or dependent on relatives were selected and grouped to form youth groups at *Got* (sub-village) level. *Got* level formations were preferred for two reasons:

- 1. To reduce the number of members per group.
- 2. To take advantage of household proximity of members to each other to facilitate better communication and coordination among the members.

Each youth group appointed a chairperson and secretary and was officially registered as a sheep fattening group at their respective *Kebele* (village) Administrative offices.

Profiling of the youth groups showed 59.8% are male and 40.2% are female. On average, there are 6.5±2.2 males and 4.3±2.3 female members per youth group. The majority (90.9%) of the youth groups are of mixed-sex status, the rest are either women-only or men-only groups.

The age structure of members revealed that majority (83.3%) of them are 15-30 years of age and the mean age of members is 25.59±7.1 years. 62.2% are married. Single, unmarried members, who comprise 37.1%, are financially dependent on their families. Majority expressed a sense of relief and gratitude to the project for giving them a sense of financial freedom and resource ownership. The educational status of members shows that majority (84.2%) of the youth have formal education, with an average of 5th - 8th Grade. The involvement of educated youth signals promise in behaviour change as pertains traditional fattening practices towards improved practices. Table 3 summarizes statistics of youth members in individual sites.

Selection and profiling of champion farmers

A total of 44 champions were selected on the basis of at least 5 years in commercial sheep fattening. One champion farmer was selected from each *Got* (sub-village) that hosted a youth group. Champion farmer were given orientation on objectives and activities of the project along with the youth groups. Profiling of champion farmers was undertaken by ICARDA and NARS researchers with assistance from project enumerators. A summary of their descriptive statistics is shown in Table 4. Majority of the champions are literate. In Bonga and Doyogena, they are mostly mixed farmers, unlike menz where 50% are purely livestock farmers. Nevertheles, only 50% of the champions have received previous training in sheep fattening. This emphasizes the necessity of capacity building for champion farmers.

Formation of Community of Practice

One CoP was formed in each region. Initially the CoPs comprise of members from NARS, youth group leaders, champion farmers, CBBP sub-committees, Government officers and Development workers. The main role of the CoPs is to keep abreast of the developments in the sheep value chain and inform project objectives and activities accordingly. It is intended that the CoP become more active and integrate additional members from amongst sheep value chain players. It is hoped that within 3 years, CoPs would have developed a life of their own, and move forward sustainably. Table 5 shows the current members of the CoP in each site.

Memorandum of Understanding

A memorandum of Understanding for collaborative activities pertaining to the TAAT project was signed between ICARDA and ARARI as well as ICARDA and SARI for the period between September 2018 and 31 January 2019.
