

## Survey of Agricultural Biodiversity Assessment for Ghana

**Selection of interviewees:** This questionnaire will be applied together to the male head of household, and to the female that will be interviewed for the Dietary Diversity section. The selection criterion for that woman is as follows: (1) a mother in the household between 15-49 years old with a child aged between 6-59 months. In the case that there are several mothers with children of 6-59 months in the household, thus eligible, choose one of the mothers randomly. Similarly if the selected mother has more than one child in the target age group, chose one of them randomly. If no mother with a child in this age group is present in the household, chose the woman who customarily prepares the food in the household irrespective of age (see additional instructions for the dietary diversity section). Most of the questions about species refer to a specific season of reference (either the wet season 2013 or the dry season 2013/14).
