## Introduction

To effectively implement the Kaleidoscope Model for understanding policy change, for each studied policy a minimum of 20 policy actors (whatever their influence) must be interviewed this sample must include different categories (Government, research, development, private, donors. Etc). The process of data collection can be tracked as presented in Table 1.

The main objectives of these interviews are to gather insights on the policy system and its dynamics, to identify key stakeholders and their roles in policy change and to understand the factors influencing policy decisions.
